### SMT. CHANDIBAI HIMATHMAL MANSUKHANI COLLEGE

ULHASNAGAR – 421 003

(Affiliated to University of Mumbai)

(Recognised and Aided by Government of Maharashtra)

Established in 1965, by the Hyderabad (Sind) National Collegiate Board (HSNC' Board) has set up more than 18 Higher Educational Institutes in Mumbai and its suburbs. Today it has emerged as a nodal centre for Higher Education in Thane District, with more than 10,000 students on roll. In this way, it is one of the largest colleges affiliated to the University of Mum,bai. It also has 400 teachers (Junior, Degree and Unaided) and 150 non-teaching staff members. It offer 27 courses in the Arts, Science and Commerce faculties at the Undergraduate level, 12 postgraduate Courses, and research leading to Ph.D. Degree in 07 departments. It also had 03 UGC sponsored community outreach Centres. Since 2003, more than 40 students have figured in the merit list of the final year examinations of the University. Smt CHM College is situated right opposite Ulhasnagar railway station and located about 60 kms. from Mumbai in lush surroundings, in an area of 16 acres, with spacious classrooms, library, office, staff-common room, canteen, annex building and very well developed Sports Grounds.

The National Service Scheme has literally grown from strength to strength from 100 in 2001 to 250 in 2008. The College with strong units of N.S.S., N.C.C., Sports, has emerged as the focal point of Extension activities organised in the city in co-ordination with UGC Sponsored Women's Study Center, Gandhian Studies Center, The involvement of the students in various outreach programmes has ensured that they imbibe social values, and are sensitized towards social commitment. Further, their knowledge and skills are used not only for personal enrichment, but also for the service of society.

## *Scheme of Examination*

### **XI Arts, Science & Commerce**

There will be 2 Unit Test of 50 marks each in the middle of each term and 2 Term End Examination of 100 marks at the end of each term.

The Unit Test will be bifurcated as follows:

- a) 30 Marks Theory
- b) 20 Marks Internal Assessment
- Total 50 Marks

Each Term End Examination shall be of 100 marks in every subject;

A) Languages (English, Hindi, Sindhi, Marathi)	80 marks theory 20 Marks Orals
B) Science (Physics, Chemistry, Biology)	80 Marks Theory 20 Marks Practical
C) Information Technology	80 Marks Theory 20 Marks Practical
D) Commerce (S.P, O.C., B.K.)	100 Marks Theory
E) Mathematics	80 Marks Theory 20 Marks Practical
F) Geography	80 Marks Theory 20 Marks Practical
G) Arts (Eco. Socio., Hist, Psychology, Pol.Sci)	100 Marks Theory
H) Environment Education	60 Marks Theory 40 Marks Project

Students are required to pass theory and project in environment education separately.

Please Note

- a) The average score of students shall be out of 300/3 in each subject
- b) Student will pass FYJC exams if he / she scores a min avg. score of 35 in each subject

### **XII Arts, Science & Commerce**

Before HSC Board Examinations College Conducts Term End Examination, Open Book Test and Prelim Examination.



- 12 The result of this re-examination will be declared within a week's time so as to enable the successful student to seek admission in the second year of the Junior College.
- 13 There shall be no extra fees for the re-examination of students.
- 14 Students failing at the examination for the First Year of Junior College, i.e. Higher Secondary Std. XI are permitted to appear as regular students for F.Y.J.C., if they desire so.
- 15 Candidates who have failed at the first year of Junior College examination shall have an option to claim exemption in the subject/s in which they have secured minimum passing marks at the previous exam/s. Candidate who do not desire to claim exemption and wish to appear for the whole examination the results of these students shall be declared as per Rul No. 3.
- 16 The implementation of the first second term end examination of F.Y.J.C. class should be as per the subject wise scheme given in Appendix - A of Syllabi for std. XI and XII.
- 17 The circulars regarding the language subjects, Environment and project work have been sent separately. These circulars should be followed accordingly.
- 18 The Annual work marks allotment for the subjects (except the subject mentioned in the rule no. 18) is as follows.

- 19 Holding of an examination for private students of Standard XI of the Junior College concerned is binding on the Principal / Headmaster.
- 20 The students who pass the F.Y.J.C. (Std. XI) examination be awarded the following Grades.
- Grade I With distinction : To successful candidates who obtain not less than 75% marks in the aggregate, calculated on the basis of the six (in case of vocational subject) or seven subjects offered the examination.
- Grade II To successful candidates who obtain not the less than 45% marks but less than 60% marks in the aggregate calculate on the basis of six (in case of vocational subject) or seven subjects offered for the examination.
- Grade Pass to all other successful candidates.
- Provided that the first (with distinction or First Second Grade shall not be awarded to a candidate who appears for the examination with any exemptions claimed by him / her.
- Provided further that if the aggregate total of marks obtained by a candidate, is less than the total marks of marks required for obtaining the first grade, but not more than 3 marks, only such candidate shall be given the necessary grace marks not exceeding there in computing his aggregate of marks for the purpose of awards of marks for the purpose of award of the first Grade.

Ours is the First College in the state of Maharashtra to be awarded the Women's Studies Centre by the UGC. The major Project of the WSC has been the Adult Education Progamme in which the Centre motivates and sponsors women from the lower economic strata of society. The other activities of the Centre are SHE (Shelter of Health and Education) in collaboration with the local administration Ulhasnagar Municipal Corporation and Kaivalyadhama, Lonavala, the premier Yoga Institute of India. ### **Admission to F.Y.J.C.**

The College enjoys the status of Sindhi Linguistic Minority Institution. Hence a certain percentage of seats are reserved for Sindhi Linguistic Minority students.

Categories for admission are as follows:

- A : Open Merit
- B : Sindhi Linguistic Minority
- C : In house quota
- D : Sports and Cultural Activities.
- E : Government, transfer cases, Defence, Freedom Fighters
- F : Handicapped

Documents Required for All above mentioned categories at the Time of Admission:

1. Admission form duly completed
2. Original Marksheet SSC or Equivalent + 2 attested xerox copies.
3. Original School Leaving Certificate + 2 attested xerox copies.
4. One Xerox copy of the first and the last page of Ration Card (For girls applying for government freeship staying in Maharashtra for more than 15 years and upto the second child)
5. One Xerox copy of the first and the last page of Ration Card / Electricity Bill / Telephone Bill / House Tax Bill / Passport or any other proof (as a residential proof)
6. Eligibility certificate (for students other than Maharashtra Board)

Additional Document Required for :

Category - B: Sindhi Linguistic Minority

Sindhi Linguistic Certificate/Undertaking on Stamp Paper of Rs.50/-  
(See Specimen on Page No.31)

Category D: Sports & Cultural activities.

Category F: Handicapped.

Proof from specific insitutions like Aliyavar Jung National Institute for hearing impaired, Worli Rehabilitation Centre for Dyslexia, Dysgraphia & Dyscalculia. Certificate of dissability from Nair or Sion from appropriate authority.



### Explanation

So far as the F.Y.J.C. classes are concerned, the academic year should be deemed to have commenced from eighth working day (i.e. excluding Sunday & Public Holidays) from and including the day of declaration of the S.S.C. Exam results. If the said day of declaration of results is a Sunday or a Public Holiday.

(b) If a student desires to withdraw and applied for refund of fees after the commencement of the academic year (vide explanation under (a) above, the institution concerned should retain the admission fee, term fee and laboratory fee (if any) in full. The Library and Laboratory deposit should however be refunded. So far as the tuition fee is concerned, the institution should retain the tuition fee only for the months (s) beginning from the month in which the academic year had commenced and ending with the month in which the student had applied for withdrawal and refund of fees. The tuition fee for the remaining months, of the term should be commenced in that month itself, the institution should retain the proportionate amount of tuition fee for one month only, namely the month of July. On the other Hand, if a student applied for refund of fees in the month of August, after the academic year had commenced in month of July, the institution should retain the proportionate amount of tuition fee for two months only, namely the months of July and August. If a student applies for refund of fees in the month of August after the academic year had commenced in the month of June, the institution should retain the proportionate amount of tuition fee for three months only, namely, the month of June, July and August)

## WARNING

*Ragging is strictly prohibited in the college premises and outside students indulging in ragging other students will be punished as per 'The Maharashtra Prohibition of Ragging Act, 1999 (Mah. XXXVIII of 1999) Published in Maharashtra Government. Gazette on 15th May, 1999. Such students will also be expelled from the college and F.I.R. will be lodged with the police against them. Moreover, it will be mentioned in the college leaving certificate of such students that they are expelled because of their indulgence in ragging.*

## *General College Rules*

---

- 1) Every student must obtain on admission the Identity Card which must have his / her photograph duly attested and present it for inspection on demand.
- 2) Every student is required to maintain a minimum of 75% attendance in each term in each subject, failing which the college authorities may not allow the student to appear at the final examination, as per University Norms.
- 3) Students must not loiter in the college premises while the classes are going on.
- 4) In case of illness, the Principal should be informed by the parents personally.
- 5) Students must not attend classes other than their own with permission of the Principal.
- 6) Smoking is strictly prohibited in the college premises.
- 7) Students are required to maintain strict discipline and orderly conduct and refrain from engaging themselves in any kind of unruly behaviour.
- 8) No Society or Association shall be formed in the College and no person invited to address a meeting without Principal's prior permission.
- 9) No student shall collect any money or contribution for picnic, trip, educational visit to some place, get together, study notes, charity or any other activity without prior sanction from the Principal
- 10) No student will be allowed to take active part in current politics.
- 11) No student shall communicate any information or write about matters dealing with the College administration to the Press.
- 12) Students are expected to take proper care of college property and help in keeping the premises clean. Damaging college property e.g. disfiguring walls, doors, fittings, or breaking furniture, misuse of A.C. etc.. will be considered as a breach of discipline and the guilty will be duly punished.
- 13) Students should not leave their books valuable and other belongings in the classroom.
- 14) The College is not responsible for lost property. However students may make a claim for lost property at the Office, if it is deposited in the College Office.
- 15) Students applying for certificates, testimonials etc. and those requiring the Principal's signature on any kind of document or application should first contact the college office. Students should not bring any paper, directly to the Principal for his / her signature.
- 16) If, for any reason, the continuance of a student in the College, is in the opinion of the Principal, detrimental to the best interest of the College, the Principal may ask such a student to leave the college without assigning reason for his / her decision.
- 17) Students joining the College are bound by the rules and regulations of the college.
- 18) Insubordination and abusive language or misconduct on the part of a student are sufficient reasons for his / her suspension or dismissal.
- 19) Students receiving Government or College Scholarships or any remission in fees must note that the grant and continuance thereof are subject to

### **Freeship to the Children of Economically backward Class / Primary/Secondary Teachers/Non-Teaching Staff/Ex-Servicemen/Freedom Fighters**

#### **A) Freeship to Children of Economically Backward Class**

- i) Those students whose parents / guardian annual income is Rs. 15,000/- or below are eligible for E.B.C. Freeship
- ii) Students who wish to apply for E.B.C. Freeship should apply in prescribed application form duly filled in and signed by S.E.O. (Special Executive Officer, Govt. of Maharashtra ) and submit the same along with admission form.

#### **B) Freeship to Children of Primary Teachers / Secondary Teachers / Non-Teaching Staff / Ex-servicemen / Freedom Fighters.**

- i) Those students who wish to apply for P.T.C. / S.S.T. / N.T.S./ Ex-Servicemen / Freedom Fighter freeship are required to apply in prescribed application form duly filled in and signed by Headmaster / Headmistress for Children of Primary Teacher, Secondary Teacher & Non-Teaching Staff and counter signed by Block Development Officer, in case of Primary Teachers Only.
- ii) The Following documents are required to be enclosed alongwith above freeships Form:
  - a) Two attested Photocopies of Marksheet,
  - b) Two attested Photocopies of Fee Receipt.
  - c) Two attested Photocopies of Ration Card.

***The students must follow these rules strictly. Incomplete form will not be accepted under any circumstances. As per ordinance No. 119 Students who do not have a minimum 75% attendance will not be eligible for any kind of freeship***

### **STATE GOVERNMENT OPEN MERIT SCHOLARSHIP (FRESH AWARD) TO DEGREE COLLEGE STUDENTS**

Those students who have secured 75% and above in the H.S.C. Examination can apply for the state Government Open Merit Scholarship (Fresh Award)

Students can get renewal of such Scholarship in S.Y. & T.Y., provided they secure minimum 50% of marks & fill up the Annual Progress Report Form within 7 days from the date of admission.
